Academic calendar University of Groningen

- › 1 academic year = 42 weeks (sept 5 – july 14)
- › 4 blocks of 10 weeks -> 7 wks lectures, tutorials etc
3 wks exams + resits
- › 2 wks resits at the end of the year



Credits

- › Academic year (40-42 weeks): 60 ECTS credits
- › Semester (20-21 weeks): 30 ECTS credits
- › Block (10 weeks) 15 ECTS credits
- › 42 weeks; 40 hours per week; -> 1680 hours /year
- › 1 ECTS = $1680/60 = 28$ hours workload
